### **General rental and sales conditions of lodgings and vacation chalets**

- The booking of a chalet implies the compliance to our renting conditions.
- All booking must be enclosed with a deposit. The total amount must be carried out at least 30 days prior to the beginning of the stay. Any client not having settled the total payment before the agreed upon date will be considered as having cancelled their reservation (unless otherwise agreed upon). No client should have the possibility to contest such a cancellation.
- For reservations made less than one month before the beginning of the stay, complete payment is required at the time of booking.
- Reservations will be considered final only after the payment has been received, despite any confirmation made by phone.
- Client will be mailed by return a receipt corresponding to the amount of the deposit together with the confirmation of the dates of the agreed period of reservation.
- All rentals are made in the name of one individual and cannot be written over or sublet to another individual.
- Delayed arrivals: clients are required to inform about any delay concerning the agreed date of arrival. In case the client fails to comply with these regulations, the chalet will be considered available within 24 hours . (All phone calls and messages will be disregarded).
- Clients will not be granted any price reductions due to late arrival or early departure.
- Place of jurisdiction: in the unlikely event that a dispute should arise, we aim to resolve the situation in the most amicable way possible. In the absence of such an agreement, only the court of Aubenas will be regarded as competent to settle the matter.
